The Aid and Attendance Pension Benefit

The Veterans Administration has a pension benefit known as Aid and Attendance to help veterans and their surviving spouses pay for in-home caregiving. This entitlement benefit was established in 1952 under Title 38 USC. This tax free stipend is paid directly to the client to cover the cost of your in-home care. We can help you apply for these important benefits and in many cases, we can begin providing care while your application is still being processed by the VA.

Veteran Aid & Attendance Eligibility Requirements

MILITARY SERVICE:

- Veteran must have served at least 90 days of active duty, with at least 1 day during war time*
- Must have an honorable or general discharge
- Serving overseas or in a combat zone is not a requirement for this benefit

Under current law, VA recognizes the following wartime periods

- World War II (December 7, 1941 – December 31, 1946)
- Korean conflict (June 27, 1950 – January 31, 1955)
- Vietnam era (February 28, 1961 – May 7, 1975)
- Gulf War (August 2, 1990 – present)

MEDICAL:

- Do you have a medical condition causing you to need assistance with everyday living?

MONEY:

- Is your net worth under \$159, 239 not including your home or car?
- Medical and long-term care expenses may reduce your net worth, thus improving your chances of eligibility

MARRIAGE (FOR SURVIVING SPOUSES):

- Were you married to a wartime veteran for at least one year?
- Were you married to the veteran at the time of his/her death?
- Have you remained unmarried or did you remarry after January 1, 1971 and your remarriage ended before November 11, 1990?
